
#### VIOLENT DEATH IN NORTH CAROLINA: CONGRESSIONAL DISTRICT 3, 2022

• An estimated 768,524 North Carolina residents reside in Congressional District 3.

- In 2022, there were 193 violent deaths from injuries sustained by individuals living in Congressional District 3.
- The majority of decedents were residents of Onslow (26.8%), Pitt (20.1%), and Craven (15.5%) counties.



Manner of Death: Congressional District 3, NC\*




• There were 131 suicides (67.5%), 50 homicides (25.8%), three unintentional firearm deaths (1.5%), four deaths from legal intervention (2.1%) and six deaths of undetermined intent (3.1%).

- Firearms were involved in 61.8% of suicides and 60% of homicides.
- Among homicides caused by firearms, 63.3% were caused by handguns, 0% were caused by shotguns, and 20% were caused by rifles.
- Among suicides caused by firearms, 84% were caused by handguns, 7.4% were caused by shotguns, and 4.9% were caused by rifles.
- The second leading method of death for suicide was hanging, strangulation, or suffocation (20.6%).

### Firearms were involved in 61.3% of all homicide and suicide deaths


Method of Death: Congressional District 3, NC\*

The North Carolina Violent Death Reporting System (NC-VDRS) is a CDC-funded statewide surveillance system that collects detailed information on violent deaths that occur in North Carolina, including homicide, suicide, unintentional firearm deaths, legal intervention and deaths of undetermined intent. NC-VDRS triangulates information from death certificates, medical examiner reports, and law enforcement reports to understand and aid in the prevention of violent deaths. Data reported in this document are based on residential address of the victim and, instead of a rate, the ratio is reported. This document summarizes fatal injuries from violence that occurred in Congressional District 3 for the year 2022. Since not all deaths resulting from violence are able to be geocoded, the violent death numbers represented in this fact sheet may be slightly underestimated.


Age Group

- Suicides and homicides displayed different age patterns.
- However, both homicides and suicides peaked among those 35-44 with 28.0% of total homicides and 20.6% total suicides.
- Percentage of overall violent deaths peaked among those 35-44 at 23.2% of total violent deaths.


- \*Age group percents are taken of total homicide, total suicide and total overall violent deaths
- The majority of suicide and homicide victims were male. There were 95 male suicide victims and 38 male homicide victims, which accounted for 72.5% and 76.0% of victims respectively.
- There were 36 female suicide victims and 12 female homicide victims, which accounted for 27.5% and 24.0% of victims respectively.

#### Uneven distributions are seen among race and manner of death



- Patterns of suicide and homicide differed by race. 77.9% of suicide victims were Non-Hispanic (NH) White while only 9.9% were NH Black.
- In contrast, 66.0% of homicide victims were NH Black, and 26.0% were NH White.
- Overall, there were 16 (8.3%) Hispanic, 120 (61.9%) NH White, 53 (27.3%) NH Black, 2 (1.0%) NH American Indian, and 2 (1.0%) NH Asian victims.
